General Terms & Conditions:

1. Information on how to enter and the prizes to be won form part of these Terms and Conditions. Participation in this Competition is deemed acceptance of these Terms and Conditions.
2. The Promoter of the Competition is PureSkiing.
3. The Competition will be run from 09h00 on 6 January 2020 until 09h00 on 20 April 2020.
4. The closing date for the Competition is at 09h00 on 20 April 2020.
5. No late entries will be considered.
6. The winner will be randomly drawn and cannot be changed unless the winner is unable to claim his or her prize, or if the promoters deem the prize winner unsuitable.

Entry Mechanics:

7. The Competition is only open to South African residents aged 18 years or over who may only enter in their own name and surname. These details will be capture by PureSkiing.
8. The Competition excludes directors, employees or agents of the Promoters and their families, affiliated companies, and public relations and advertising agencies of the Promoters or any other person who directly or indirectly controls or is controlled by the Promoters or a supplier of goods or services in connection with the Competition.
9. To be entered and participate in the Competition, entrants must like, share and follow PureSkiing on Instagram and Facebook.
10. Entry is free and conditional apply in accordance with PureSkiings T&C's.
11. By entering the Competition, the entrant gives consent to the Promoters to:
 - a. Store their home city, name, cell phone number and email address;

13. The First valid entry drawn will win the Prize.
14. Should the draw be postponed to another date, for any reason whatsoever, a new draw date will be announced on PureSkiing social sites, no later than 5 days after the original draw should have taken place.
15. The winner of the Prize will be notified by social media within 2 working days of the draw. If any of the winners fail to claim their Prize within 1 working day of receiving such notification

- from the Promoters, he/she will forfeit their Prize and the promoters will conduct a further draw, as required.
16. Following notification, details will be sent to the winners outlining the process for redeeming their Prize.

2. The promoters do not hold any responsibility for any damages which occur as a result of the competition prize.

The Promoters reserve the right to verify the validity of entries and to disqualify any entrant (including a winner) who tampers with the entry process, who submits an entry that is not in accordance with these Terms & Conditions or who has, in the opinion of the Promoters engaged in conduct in entering the Competition which is fraudulent, misleading, deceptive or generally damaging to the goodwill or reputation of the Promoters.
4. The Promoters reserve the right in their sole discretion to disqualify any individual who the Promoters have reason to believe has breached any of these Terms & Conditions, or engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and

proper conduct of the Competition. The Promoters legal rights to recover damages or other compensation from such an offender are reserved
